**PAYMENTS:** Payments to Cuba Life Travels, LLC. can be sent via institutional checks (e.g. colleges or universities), certified check, cashier's check, bank transfer, or via credit card (Visa or MasterCard only). We cannot accept personal checks. Credit card payments can only be made via our Credit Card Authorization Form (attached). Credit Card payments will be charged a service fee of 3.5%.

**U.S. AUTHORIZATION TO TRAVEL:** Under the Office of Foreign Assets Control of the U.S. Department of the Treasury, Americans are allowed to travel to Cuba under one of the 12 licenses approved.

**CANCELLATION AND REFUND POLICY:**

**Requests for INDIVIDUAL arrangements to Cuba requires \$500 non-refundable deposit. Balance is due upon receipt of your invoice.** Individual arrangements are subject to Cuban tour policy that includes complete payment sixty (60) business days before departure date.

If your notice for cancellation is received: You will receive a refund as follows:

More than 30 business days before departure..... Refund less \$500 deposit, \$50 reservation fee, \$80 visa fee, and airfare if issued on a non-refundable basis.

30 business days or less before departure..... No refund.

We suggest that any person who will be connecting into their point of departure from a different city consider doing an overnight stay on both the night before the departure to Cuba and the night of the arrival from Cuba.

Above charges do not include cancellation charges imposed by the airlines for any connecting flights to/from your point of departure to Cuba. Cuba Life Travels, LLC is not responsible for any charges incurred if your charter flight to/from Cuba is delayed for any reason.

Cuba Life Travels, LLC accepts no responsibility for the issuance or denial of licenses by the Office of Foreign Assets Control nor for the issuance or denial of visas by Cuba or any third party mishaps. And please be aware that optional excursions are not included in the price.

**RESPONSIBILITIES**

Cuba Life Travels, LLC and its employees, shareholders, officers, directors, successors, agents, and assigns, neither own nor operate any person or entity with which it does business with, provide goods or services for these trips or tours. Cuba Life Travels, LLC does not maintain any control over the personnel, equipment, or operations of their suppliers. Cuba Life Travels, LLC assumes no responsibility for and cannot be held liable for any personal injury, death, property damage, or other loss, accident, delay, inconvenience, or irregularity which may be occasioned by reason of (1) any wrongful, negligent, willful, or unauthorized acts or omissions on the part of any of the tour suppliers, or other employees of agents, (2) any defect in or failure of any vehicle, equipment, instrument owned, operated or otherwise by any of these suppliers/vendors, or (3) any wrongful, willful, or negligent act or omissions on any part of any other party not under the supervision or control of the operator (4) sickness, weather, strikes, hostilities, wars, terrorist acts, acts of nature, local laws or other such causes. Traveler should use their best judgment while in Cuba. Solicitation of any kind is illegal in the visiting country of Cuba. Any and all legal fees will be assumed by the traveler and not Cuba Life Travels, LLC. Cuba Life Travels, LLC will not be responsible for any legal representation during the visit in Cuba or thereafter. Traveler assumes all risks if they chose to disobey Cuba law.

By signing this application and submitting it for travel to Cuba with Cuba Life Travels, LLC, with the non-refundable deposit, the traveler agrees they have read and understood the terms of traveling to Cuba.
